

**Mtn Dew Kickstart™ “Closer than Courtside™” Contest
Official Rules**

PARTICIPATION SUBJECT TO COMPLETE OFFICIAL RULES AVAILABLE AT www.MountainDew.com/Courtside. CONTEST SHALL BE CONSTRUED AND EVALUATED ACCORDING TO THE LAWS OF THE STATE OF NEW YORK. VOID WHERE PROHIBITED.

1. CONTEST PERIOD: The Mtn Dew Kickstart™ “Closer than Courtside” contest (the “Contest”) begins February 15, 2018 at 12:00 p.m. Eastern Time (“ET”) and ends at 11:59 p.m. ET on April 4, 2018 (the “Contest Period”). The computer clock of Sponsor’s webmaster is the official time-keeping device of the Contest.

2. ELIGIBILITY: To be eligible to win, you must be 18 years of age or older (19 in AL and NE) and a legal resident of the U.S. residing in one of the fifty (50) United States or the District of Columbia throughout the Contest Period. Potential winner may be required to provide proof of legal U.S. residency if requested by Sponsor to determine eligibility and as a condition of prize award. Limit one hundred Submissions per Entrant across all Social Media platforms during the Contest Period. Entrant’s Social Media profile must be public in order for Sponsor to be able to contact you if you are a finalist or the potential winner. If you are not a registered account holder of any Social Media account, you can visit one or more of the Social Media websites and follow the instructions to register for a free account. - Hashtags and uploads must be in English.
- Each photo/video cannot be used more than one (1) time throughout the Contest Period.

JUDGING AND SELECTION OF FINALISTS: Beginning March 20, 2018 through March 26, 2018 (“Judging Period”) all eligible Submissions received in the Contest will be judged by a panel of judges from Sponsor (“Judges”) to determine the five (5) finalist Submissions (“Finalists”). The Judges will score each Submission according to the following weighted judging criteria (collectively, “Judging Criteria”):

Creativity/originality of Submission – 33%;
Relevance to theme – 34%; and,
Quality of Submission content – 33%.

Once the five (5) Finalists have been chosen, they will be posted on the Website for consumers to vote for their favorite Finalist Submission.

7. FINALIST VOTING: Between 12:00 a.m. ET on March 27, 2018 and 11:59 p.m. ET on April 4, 2018 (the “Voting Period”) consumers will be allowed to vote on their favorite Finalist Submission. The Voting portion of this Contest is open to consumers who are 18 years of age or older at the time of voting who register on the Website by providing their name, e-mail

address, date of birth and create a password. There is a limit of one (1) vote per person, per day during the Voting Period. For purposes of these rules, a day is defined as 12:00 a.m. ET through 11:59 p.m. ET.

Once the Voting Period has ended, the Sponsor will tally up the number of votes for each Finalist Submission. The Finalist Submission with the greatest number of votes will be deemed the Winner. If there is a tie among the Finalist Submissions after the Voting Period has ended, the Sponsor will review the tied Submissions and will break the tie based on the Judging Criteria stated above.

The Grand Prize consists of a trip for two (2) people (winner and one guest) to one (1) game during the 2018 NBA Playoffs (scheduled for April 14, 2018 through May 30, 2018) and the opportunity to sit courtside with Kevin Hart while at the game (based on Mr. Hart's availability). Grand Prize includes two (2) tickets to a game during the 2018 NBA Playoffs (game selected by Sponsor), round-trip coach air transportation for two (2) from an airport near winner's home within the U.S. (airport, carrier and itinerary selected by Sponsor), one (1) double occupancy standard hotel room for one (1) night, ground transportation and an opportunity to sit courtside with Kevin Hart at the game (based on Mr. Hart's availability).
